HEALTH ITALIA OPENS THE NINTH HEALTH POINT

Today, Tuesday 25 September, Health Italia S.p.A. through the subsidiary (100%) Health Point Srl, will open another Health Point Center in Rome, increasing to nine the total number of facilities located throughout the country.

Health Italia SpA, an innovative SME listed on the AIM Italia market, among the largest independent companies of the Italian market operating in Integrative Health, announces that today, in Via Giacomo Trevis in Rome, the ninth "Health Point" will be inaugurated, a structure focused on the provision of remote medical services through a specific and innovative technologically advanced project, aimed at creating an advanced model of telemedicine.

The new Health Point will be opened in collaboration with the ENBIMS, ENBIF, ENBIC and CISAL Terziario bilateral bodies, in line with the Group's strategic desire to disseminate the advanced model of telemedicine, in collaboration with representatives of the social partners.

The Health Points openings and the simultaneous spread of the innovative model developed by the Health Italia Group are proceeding faster, compared to our expectations, with a view to providing health services carried out through advanced and certified systems of telemedicine in a logic of proximity to customers and accessibility for citizens with particular attention to prevention.

The **strategic assumption of the project** is based on the certainty that the health care market must operate with technologically advanced models that guarantee broad usability to citizens in line with the group's mission.

The new opening will contribute to achieving the objectives of the project managed through Health Point Srl which, as expressed in the guidelines of the business plan for the three-year period 2018-2020, envisage the opening of at least 20 Health Points by the end of the same three-year period.

The Director of Health Point Srl, Silvia Fiorini commented on the opening of the ninth structure: *"We are very satisfied to be already present on the national territory with nine facilities after only a few months from the start of the project. We decided to focus on an intense growth in the number of Health Points on the country, even in respect of major investments, as our role will be decisive in*

achieving the results expected for the whole Group in the Business Plan 2018-2020 and we are ready to achieve the preset goals in a short time. "
